 - A. ACTION ITEM: [Club Funding Requests](#)
The Finance committee will be taking action on club funding requests.
P. Ayyagari goes through the club funding request submitted by Jonathan M. Crescenzo representing The Bad Designers Club for the event Pioneer ThinkDown Challenge that would be held on March 26th, 27th, 28th, 2024. The application is submitted on March 4th, 2024. She states that they requested for an amount of \$438.17. She states that the club did not meet the 30-calendar day requirement and hence, is ineligible for club funding.
N. Sharma goes through the application submitted by Vishwajit S. Bhosale, representing the Hindu Yuva Club for the event Holi. The application was submitted on March 3rd, 2024, and the event is supposed to be held on March 25th, 2024. She adds that they requested for an amount of \$1500 and the request is ineligible as they did not meet the 30-calender day requirement.

The Finance committee will review the applications of club funding requests and ensure they meet the requirements.

R. Pagadala goes through the Cultural Graduation Funding request submitted by Rin K. Anderson, representing Lavender Graduation Celebration Committee. The event is supposed to be held on May 5th, 2024, and the application was submitted on March 7th, 2024. She adds that the club requested for an amount of \$6906.83 and states that the club is eligible for a funding of \$5000. As the maximum amount of funding received per ceremony is \$5000 according to ASI Student Cultural Graduation Funding Policy.

P. Ayyagari reviews the application submitted by Jonathan M. Crescenzo, representing The Bad Designers Club for the event “The Pioneer ThinkDown Challenge: Presentation & Awards.” She states that the application is submitted on March 8th, 2024, and the event is supposed to be held on April 12th, 2024. She adds that an amount of \$1442.88 is requested by them. She states that The Bad Designers Club is eligible for \$1000 and quotes that according to ASI Club Funding Policy, “The maximum amount that any one club or organization can be granted for one event is \$1000.”

N. Sharma reviews the Cultural Graduation Funding request submitted by Crystal M. Chavira-Ordunez representing Chicanx/Latinx Graduation Celebration Committee club on March 13th, 2024, for the event Chicanx/Latinx Graduation Celebration which would be held on May 4th, 2024. She adds that the club requested for an amount of \$5532.64. She states that the club is eligible for funding of an amount of \$5000 quoting the ASI Student Cultural Graduation Funding policy.
