I. Welcome and Introductions

- What's working well with fieldworkers/interns?

*Trainees' skill preparation, professionalism, and general readiness to work with pupils in schools
Quality of counseling, assessment, and communication*

- Supervisor Handbook & Crisis Documentation- *Dr. Greg Jennings and Ms. Angela Tang presented the Crisis Incident Report Form (CIRF) as a new mandatory trainee*

documentation of ALL incidents occurring in schools that require consultation- including suspected child abuse, harm to self or others, or ethical dilemmas.

- *Strength-Based Social-Emotional Assessment & Intervention- Dr. Greg Jennings presented CoVitality mental wellness measures and ongoing team research at CSUEB.*

School Counseling (SC) and School Psychology (SP) supervisors met with Program Coordinators- Dr. Greg Jennings (SP) and Ms. Angela Tang (SC).
