POSITION AVAILABLE: One or more temporary, part-time lecturers for a pool from which instructors will be considered for appointments as they become available for Fall Semester 2018 and/or Spring Semester 2019.

THE DEPARTMENT: The Department of Speech, Language, and Hearing Sciences is accredited by the American Speech and Hearing Association and offers the Bachelor and Master of Science degrees in Speech-Language Pathology and/or Audiology. There are approximately 200 majors and five regular faculty.

DUTIES OF THE POSITION: Teaching one or more basic and advanced course(s) for undergraduate and graduate students in the areas of Speech-Language Pathology and/or Audiology. Please note that teaching assignments at California State University, East Bay include courses at the Hayward, Concord and Online campuses.

RANK AND SALARY: Lecturer. Salary is dependent upon educational preparation and experience. Position appointment is subject to budgetary authorization.

DATES OF APPOINTMENT: Fall Semester begins August 17, 2018; Spring Semester begins January 22, 2019.

QUALIFICATIONS: Ph.D. or Master's degree in communication disorders, and academic and practical expertise. University teaching experience is preferred. CA State License & Board Certification by ASHA in Speech-Language Pathology and/or Audiology is preferred. In addition, candidates seeking employment in our credential program must have: a) current knowledge of the content they teach/supervise; b) knowledge of the current context of public schooling including California's adopted P-12 content standards, framework, and accountability system; c) knowledge of diversity in society, including diverse abilities, culture, language, ethnicity, and gender orientation; and d) demonstration of effective professional practices in teaching and learning, scholarship, and service.

APPLICATION DEADLINE: Positions open until filled. Applications are considered on a continuous basis. Those presently in the pool, whether teaching or not, must submit a new letter of application for the new academic year, and a current vita.
