Resolution Regarding Appreciation for the American Association of University Professors' (AAUP)
Support of Shared Governance at the California State University (CSU)**

RATIONALE: *The CSUEB Senate recognizes that the positions expressed by the [AAUP](#) and [CA-AAUP](#) concerning the governance process join with those of 22 campuses, the CSU English Council, the CSU Math Council, the California Faculty Association, the Quantitative Reasoning Task Force, the Admissions Advisory Council, the General Education Advisory Committee, and the California Teachers Association State Council.*

We find it troubling that the March 27, 2018, [response](#) to AAUP by the CSU administration, issued two months after the ASCSU tabled AS-3309-18/AA [Rev]: Shared Governance and Consultation in the CSU and following several meetings of ASCSU and CSU administration on shared governance, continues to maintain that there was timely and adequate consultation on the two Executive Orders.
