a. 17-18 FAC 7

What are the effects of moving the grades due date?

- Students living on financial aid will be affected
- Students will not know how to deal with what happens in Jan.
 - To straighten out issues with grades
- International students will have a tough time sorting out visa info etc.
- Students residents won't know whether they are continuing to live on campus or not
- Taylor: Move the 3 duty days to beginning of Jan?
- Kim: Keep it how it is so make up tests etc can be done then?
 - o Hann, Zinovy, support keeping it the way it is
 - o Federal holiday in Jan would interject in beginning of schedule
- Consensus to keep the calendar the way it is currently proposed, will provide clarifying information arguing for its current form
- Student representative
 - o Want grades asap for enrollment, planning, financial issues
 - o Currently states online that grades are released Jan. 14
 - o Prefer the grades released on the 24th
- Keeping same summer turnaround is important for all the same reasons, plus we are not yet certain about what will happen in the summer session
- Will have a vote by email if necessary before next senate meeting
- Time certain: 3:05
 - o Student Financial Aid rep & Registrar Schneider:
 - Delays in grading will adversely impact students' financial aid processes
 - Pushing the date further will both make their aid packages late, not accommodate appeals, prevent students from getting refunds
 - Difficult if not impossible to reduce grade processing time, involves other offices, would need agreement from all parties involved, other departments review student records etc. and their needs dictate their turnaround
 - We are already the fastest turnaround on grades in the CSU
 - Other advantages
 - Need grades for verifications: employment, reimbursements, degree completion, ability to give degrees sooner, transcript requests
 - o Assoc. Dean Watnik
 - If someone fails a prerequisite course but is already enrolled in a course, less time works against their favor in repeating a course, sorting out issues takes time for the system to work
 - ASI President has been encouraged to have representation in the debate

 Dean Scharberg: Suggests there are many good reasons to release grades before the break, some positive (ex. good driver insurance rewards), some negative (ex. If a student needs to move out of housing)
