

Cayuse SP

Complete Grant Management Coming in early 2020

- •Cayuse automates grants from proposal creation to award close out
- •Replaces the Intent to Submit form
- •PI profiles are managed and stored by PI's so Biosketches, collaborator documents, etc. can be saved for all future proposals.
- •Profiles automatically populate a proposal.
- •Proposal documents and attachments are all electronically kept within your proposal.
- •Routing is electronic and email notifications are sent out from the system.
- •Resubmissions take a fraction of the original time.
- •Proposal applications have guideline validations to insure compliance with proposal.

Responsible Conduct of Research

- NSF & NIH requirement for training of students and post-docs supported by grants
- Federal regulation with significant implications
- Must complete CITI training ASAP

Indirect Cost Policy and Agreement

Waiving/reducing IDC is a violation of federal agreement and CO requirements

- Federal rate of 46.5% of MTDC extended until 2022
- State rate of 30% increasing to 40% by 2021
- Off campus rate only applies when grant funds are used to rent or lease a facility
- Other governmental rate
 15% minimum
- Private rate 15% TDC minimum

Principal Investigator Policy

- Eligibility tenure track faculty & MPP
- Provisional PI status may be granted for a limited time for a specific project
- Eligibility revoked for misconduct
- Policy defines responsibilities

Grant Amendments

A significant change to your project requires ORSP to process an amendment and have approvals documented with the award.

Examples that warrant an amendment would be (but are not limited to):

- •No cost extensions (changes the end date of the contract)
- •Change in scope of the project (requires sponsor approval)
- •Additional funding provided by the sponsor (contract amount)
- Change of PI
- •Various other scenarios- if you are unsure, please contact ORSP to inquire.

Sexual Assault and Harassment

CSUEB does not tolerate sexual misconduct, assault or harassment.

NSF supports scientific research but it will not support sexual harassment or assault from any PI or Co-PI on an NSF funded project.

NSF recently published a new "term and condition" to its award regulations.

All agencies who receive NSF funding are now required to report to NSF any sexual misconduct findings that have resulted in administrative actions if the person responsible for the misconduct is a PI or Co-PI on an award or subaward funded by NSF.

Based on the details of the investigation, and administrative action, a substitute PI or Co-PI may be appointed to the project.

Conferences funded by NSF are required to distribute NSF's policy on sexual misconduct to all attendees along with the procedures put in place by the campus to implement the policy.

Limited Submission Procedures


Some funding notices limit the amount of applications that can be submitted by the institution.

If the number of interested applicants who complete the Intent To Submit form exceed the allowed amount by the sponsor, pre-applications will be required from interested PI's.

Pre-applications will be submitted through InfoReady and will include a brief summary and a preliminary budget/justification.

Pre-applications will be reviewed by appropriate Deans and AVP of Research for determining which projects will be supported in full submissions to sponsor.

Paid Undergraduate Student Researchers

- Call coming soon, Due 1st week of January 2020
- Will be stipulations on GPA, Grad School Intentions, etc.
- Approximately 16 students for one semester, 20 hrs per week working on their research project
- \$4800(more than tuition for a semester which is ~\$3500)
- Faculty Mentor Applies
