

LATTC California General Education Transfer Curriculum (Cal-GETC) Certificate 2025-26

The California General Education Transfer Curriculum (Cal-GETC) is a singular, uniform pathway for California Community College (CCC) students to fulfill lower-division general education requirements for transfer to both the California State University (CSU) and the University of California (UC).

Partial Certification is not honored at CSU. **Advise with caution.** Partial Certification is more appropriate for high unit UC transfer majors, but must still fulfill the following: Partial certification of Cal-GETC allows a maximum of up two courses outstanding; from Cal-GETC areas 3, 4, 5 or 6. Students must complete the local UC GE requirements after transfer.

California General Education Transfer Curriculum (Cal-GETC) FAQs

Q: What is the California General Education Transfer Curriculum (Cal-GETC)

A: Cal-GETC is a general education pattern which community college transfer students can follow to fulfill lower-division general education requirements for either the UC or CSU systems. **This pattern is required to fulfil an Associate Degree for Transfer (ADT).** Many private/independent universities also recognize it as a viable GE pattern or accept Cal-GETC to meet their general breadth requirements. Meet with a counselor to review CSU's GE for those not following Cal-GETC.

Q: Is Cal-GETC an admission requirement?

A: Cal-GETC is required to earn an ADT for all new students starting Fall 2025. Cal-GETC is not an admission requirement, but a consideration. Completing it does not guarantee admission to the campus or program of choice. However, completing the lower-division breadth/general education requirements — whether through Cal-GETC or the campus-specific requirements — may be considered by the campus in selection among qualified applicants.

Q: Must all transfer students follow the Cal-GETC pattern to transfer to the UC or CSU?

A: NO. Community college students who are CSU bound have the option to complete the new CSU General Education requirements. The new CSU GE requirement is no longer "certified". Students who are UC bound have the option of completing:

- The general education requirements of the specific UC campus
- The minimum UC transfer admission requirements
- or Cal-GETC.

Although many UC and CSU campuses will accept full Cal-GETC certification to satisfy lower-division general education requirements, not all UC and CSU programs recommend the Cal-GETC pattern for transfer.

For example, students pursuing majors that require extensive lower-division major preparation (e.g., Engineering, Physics, Chemistry, Computer Science, etc.) may not find Cal-GETC advantageous and advise students to follow the minimum 7-course pattern for UC eligibility (2 courses in English composition; 1 course in Mathematical Concepts & Quantitative Reasoning; 4 courses chosen from at least 2 of the following subject areas: Arts & Humanities, Social & Behavioral Sciences, and Physical and Biological Sciences). NOTE: UC Berkeley's general education (GE) breadth requirements are distinct from the Cal-GETC (California General Education Transfer Curriculum), and while Cal-GETC can fulfill many UC breadth requirements, it's not directly accepted for admission. UC Berkeley requires completion of a 7-course breadth requirement for the College of Letters & Science and the College of Computing, Data Science & Society, which is separate from Cal-GETC/IGETC. The specific GE breadth requirements can vary slightly by college, so students should consult the relevant college's academic guide or transfer counselor.

Q: Can I use Advanced Placement (AP) exams for Cal-GETC?

A: YES. AP exams may be applied to CAL-GETC with passing scores. For more details and up-to-date information, see the [UC AP Chart](#).

NOTE: As AP credit may satisfy general education areas, certain scores must be attained to earn specific course credit for a major. Consult each CSU or UC campus for their AP exam credit policy.

Q: Can I use evaluated foreign college transcripts for Cal-GETC certification?

A: NO. Courses from foreign institutions cannot be used for Cal-GETC certification, however, international courses can be evaluated after transfer at the receiving CSU or UC campus and applied to campus-specific breadth requirements.

Q: What is "Cal-GETC Certification" and how do I request it?

A: Cal-GETC certification is the process by which the community college verifies that a student has completed all the required coursework for the Cal-GETC.

Documentation is sent directly to the transfer institution. If Cal-GETC is not certified, students will be subject to the lower-division general education requirements of the UC campus. To request Cal-GETC certification, students should consult with a counselor for proper curricular review and sign-off.

SUMMARY

1. Minimum of 60 semester or 90 quarter UC transferable units with a minimum 2.4 GPA (non-resident students 2.8 GPA).
2. All courses taken to meet Cal-GETC requirements must be completed with a grade of "C" or better.
 - a. A grade of Credit or Pass may be used if the college's policy states it is equivalent to a grade of C or better.
 - b. No more than 14 semester (21 quarter) units of the 60 semester (90 quarter) units may be taken pass/fail or credit/no credit.
3. Students are encouraged to meet with a counselor to discuss appropriate G.E. and lower division major requirements for transfer.
4. Cal-GETC certification is governed by the California State University and University of California Chancellors Offices. The Articulation Officer has final review and determination of all course petitions applied toward Cal-GETC.
