C. ACTION ITEM: CSU Multi-year Tuition Increase Resolution

The ASI Board of Directors will be taking action on the 2023-2024 CSU Multi-year Tuition Increase Resolution.

Motion to approve the 2023-2024 Multi-Year Tuition Increase Resolution, by **H. Corum**, seconded by **G. Felix**, motion **CARRIED**.

N. Calara and a couple of Board members wrote a resolution in opposition to the Multi-Year Tuition Increase. He states that the Board of Trustees goal is to increase tuition by 6% every year. With the updated information they're going to do a 5-year review and it's going to stop after the fifth year, and we believe that 6% is a large increase. Students attend Cal State East Bay for it being affordable. There are two new points to add into their resolution, one of which is that FAFSA is having major changes in the school year 2024-2025. He states that they are replacing the Expected Family Contribution (EFC) to the Student Aid Index, and modifications to family definitions in the FAFSA formula. Although the claim states that 60% of the student population will be not affected by the tuition increase, he states that it could be lower because of FAFSA's modifications. In addition to that, Nolan states that the Graduation Initiative 2025 eliminates equity gaps regardless of racial ethnic or financial backgrounds and the tuition increase goes against that. He states that the CSUs should continue to look at the efforts of Graduation Initiative 2025. Are there any board members that would like to touch on these points?

G. Felix states they are hoping to pass this resolution and reiterates that we are opposing the Multi-Year Tuition Increase. Students can go to the Board of Trustees meetings to address their concerns.

N. Calara states that the Board of Trustees meeting will be happening on September 12 and 13.

D. Lopez recognizes Elijah Quineri at 12:19 PM.

N. Calara encourages everyone to join him during this meeting. Are there any other comments?

J. Carroll states Nolan mentions the 40% and to those who attended CSSA/CSUnity that was one of the questions that students ask to the Chancellor's office with additional clarity on who was in on that 40%. He states that it is possible that not everyone in the 40% meets the financial means to get financial aid. The Chancellor's office was not clear on who would be impacted in that 40%. James states international students would be in that 40% because they are not eligible for financial aid. He states returning students may have exhausted their financial aid and possibly be part of that 40%, and undocumented students could or could not be affected by this tuition increase. The key idea is there needs to be an understanding of who's in that 40%. He encourages the Board to ask the question in different ways to the Chancellor's Office.

A. CSUNITY 2023 Report

C. Martinez Aguilera gives a brief introduction on the previous CSUnity Report.

H. Corum raises different concerns regarding Title IX, Legislative Affairs, Graduate Initiative 2025, and the tuition increase. Any questions?

N. Calara mentions that he appreciates the team's enthusiasm when they were representing East Bay. What was the question you asked the Chancellor?

H. Corum states she asked the Chancellor, "do you truly believe that the increase in tuition will help our declining enrollment rates?" The Chancellor responds that, "there's no hard evidence."

N. Calara states this is why we out in the resolution we believe the enrollment is going to be a huge factor in that tuition increase. He encourages everyone to ask hard questions to the Chancellor and the Board of Trustees if these decisions are beneficial for students. He states that it is important to make public comments to speak your concerns. He was able to attend workshops about black student success. The presentation was led by the University President of Fresno State and Dominguez Hills. It revolved around how to increase equity gaps specifically

In addition, he was able to attend workshops on accessibility services. He mentions that CSU East Bay is one of the leading universities to support students on the spectrum. He also mentions how he wants to collaborate with accessibility.

C. Martinez Aguilera states they were also able to join different workshops. He was able to join an enrollment workshop, alumni relations, and general education classes.

E. Loredo states he attended the Title IX workshop. We were able to learn more of the call center corner assessment and what each individual university can do to create awareness.

H. Corum says if anyone is interested in the specifics, such as the salary, they can investigate transparentcalifornia.gov.

N. Calara adds the executive and president salaries in the CSU website.

D. Lopez asks if anyone wants to add to the discussion.

E. Quineri adds that if anyone is interested in how the campus supports our neurodiverse population, the CLP or college link program works with our accessibility services.

C. Chin-Newman states that the college link program is a wonderful program where people can have someone to shadow them during classes or social events. This program does not include service in the tuition, but they are paying several thousands more. This creates a barrier for families to pay for tuition. The Academic Senate is also working on a couple tasks forces, one of which is the Disability Justice Resolution. She states that it would be great to have one student representative. There would also be a task force for the academic policy.


