

## ${\bf BOD~2019\text{-}20-11R}$ Support for Mandated Undocu-Ally Trainings for CSUEB Faculty/Staff

WHEREAS, Associated Students, Incorporated (ASI) of California State University, East Bay (CSUEB) is the recognized voice of approximately 16,000 students; and

WHEREAS, it is the mission of the ASI Board of Directors to advocate and provide responsible and effective leadership for a diverse student population in order to make sound decisions for the betterment of CSUEB students; and

**WHEREAS**, ASI's Policy Agenda 2019-2020, Priority #2 Support for Undocumented/DACA Students, is "to provide support for Undocumented/DACA and mixed status families students in order to promote safety and inclusivity;" <sup>1</sup>

WHEREAS, CSUEB's Shared Strategic Commitments includes being dedicated to "enhance our inclusive campus, responding to the backgrounds and interests of our diverse community and promoting their academic, professional and personal development," and "serve students first, by expanding access and enhancing each student's educational experience and prospects for success as a graduate and life-long learner;"<sup>2</sup>

**WHEREAS**, the 2015-2016 ASI Board of Directors passed *Resolution Establishing a DREAMer Center and DREAMer Coordinator*, which urged CSUEB to "provide ally training to staff, faculty and students on undocumented inclusion and education;"<sup>3</sup>

WHEREAS, ASI recongizes that undocumented students face high education costs, do not receive any form of federal financial aid, experience increased levels of anxiety, and complete undergraduate education at lower rates<sup>4</sup>; and

**WHEREAS**, Undocu-Ally Training prepares faculty and staff to respectively address the needs and concerns of undocumented/DACA students in areas such as financial aid, federal and state policies, and scholarships to improve retention rates,

**RESOLVED**, that the University designate a specific staff person who would be responsible for providing quarterly mandatory undocu-ally training provided in order to serve the need for professional development for faculty and staff in regards to better serve undocumented/DACA students at CSUEB,

**RESOLVED**, that the University designate a specific staff person who will be responsible for providing quarterly targeted field-specific training for professionals who are in direct one-on-one contact with students, such as admissions officers, outreach coordinators, advisers, and financial aid professionals,

**RESOLVED**, that we recommend the following offices, and departments, programs on campus should be trained first: General Education, Peer Academic Coaches, Registrar, Financial Aid, Student Life and Leadership, Student Success and Equity Advising programs, Student Housing & Residence Life, and ASI Student Government (i.e. Board of Directors and Senate) and professional staff.

**RESOLVED**, that copies of this resolution be distributed to the Office of the President, Office of the Vice President for Student Affairs, Office of the Provost & Vice President of Academic Affairs, Office of Diversity, Academic Senate, Office of Student Life and Leadership, Diversity and Inclusion Student Center, the Associated Students or Associated Students Incorporated of
