

Senate 2019-20 – 1R Homelessness Awareness on CSUEB Syllabuses

WHEREAS, Associated Students, Incorporated (ASI) of California State University, East Bay (CSUEB) is the recognized voice of approximately 16,000 students; and

WHEREAS, it is the mission of the ASI Board of Directors to advocate and provide responsible and effective leadership for a diverse student population in order to make sound decisions for the betterment of CSUEB students success¹; and

WHEREAS, the purpose of the ASI Senate is to serve as the governing body of the students of CSUEB as the ASI Senate, to advance the cause of CSUEB students, and to provide programs and services designed to meet the varied needs of CSUEB students²; and let it be

WHEREAS, according to ABC7 Los Angeles News³; reports that the "California State University is the largest public university system in the country, with 460,000 students across 23 campuses" and "one in 10 California State University students are homeless."

WHEREAS, the ASI Policy Agenda 2019-2020⁴, Priority #1: Student Success and Equity, is to "enable student academic success & equity that is geared towards improving academic success as well as a higher graduation retention rate;" and, Priority #3: Basic Needs, is to "ensure [that] students [receive] further support in regards to their basic needs such as food and housing security, and access to mental health services."

WHEREAS, the California State University created a Basic Needs Initiative⁵ and found that "many students experience barriers to meeting their basic needs as they strive to earn a higher education degree."

WHEREAS, the 2018 #REALCOLLEGE SURVEY SCHOOL REPORT⁶ arranged by the Hope Center for College, Community, and Justice at Temple University in April 2019, concluded that out of the 483 CSUEB students that participated in the survey that "55% of respondents were food insecure in the prior 30 days, 60% of respondents were housing insecure in the previous year, and 17% of respondents were homeless in the previous year"

WHEREAS, the Meal Voucher Report of September 2018⁷ results were gathered by the Swipe out Hunger event at CSUEB and 176 CSUEB students who participated in submitted responses. The results are as follow:

WHEREAS, the Stupski Grant Study - Barriers to Student Success study at CUSEB in August 2018 that "64% of students worry about running out of food"

WHEREAS, H.O.P.E. is not listed on the University website under student resources and when searching for it is not easy to access and find.
