Audited Financial Statements for Fiscal Year Ending June 30, 2021

Auditor Dave Robydek of CliftonLarsonAllen LLP presented and reviewed the audited financial statements for fiscal year ending June 30, 2021. He gave a clean, unmodified opinion; no compliance or internal control deficiencies were identified.

Staff summarized the management discussion and analysis and responded to questions. The committee appreciated that management took their suggestions from last year (comparative views for detailed financial statements as well as for Investments and Pledge Receivables) and incorporated them into this year's report. The committee was pleased to hear that the audit went smoothly (given that it was performed 100% virtually), and the Educational Foundation received a clean audit with no significant weaknesses in internal controls. The committee approved the draft audited financial statements on behalf of the board.
