a. **YTD Fundraising Report**: Chair Nanninga started the report with the news that the Development team has already surpassed their fundraising goals in advance of fiscal year end on June 30. So far, they have raised \$7.3M, exceeding the \$6M goal set at the beginning of the year. The Development team also beat last year's fundraising totals to date in all Development areas, including the Annual Fund which nearly doubled their total from the prior year.

- b. **Applied Sciences Center Update**: The fundraising for the project was completed and the university is working towards a fall groundbreaking.
- c. **CORE Update**: On May 3rd the university held a special event, inviting the local indigenous tribe members to campus and having a blessing for the building. Construction is being finalized over the summer, and we are hoping for a Fall groundbreaking.

IV. Vice President's Report:

- a. The new Vice President for Advancement, Evelyn Buchanan, thanked the committee and gave a review of her first 17 days on the job. Evelyn informed the committee of her background in Development work and gave the committee a presentation that further broke out the fiscal year fundraising results in a visual format.
