All pages must be filled completely and signed before submitting the application.

☐ **\$150 Non-Refundable Application Fee**

Pay the \$150 non-refundable application fee using one of the following methods:

- **In-Person Payment:** Visit the University Cashier's office with your Net ID (CSUEB Student ID). Payment can be made via cashier's check, personal check, or money order made payable to [CSUEB](#).
- **Online Payment ([CASHNET](#)):** You can pay online only after submitting your application and receiving your Net ID (CSUEB Student ID).

☐ **Verification of Finances**

Attach bank statements, letters, or seals to verify your financial support.

☐ **Copy of Passport**

Attach a copy of your passport with your photo and personal information. Attach a copy of your dependents' passports, if applicable.

If you're planning to pursue Undergraduate or Graduate Programs at CSUEB after completion of the Intensive English Program, submit the following additional documents:

☐ **Copies of Official Academic Records**

Attach copies of official academic records (diplomas/transcripts) from your secondary school and any colleges or universities you have attended.

- Transcripts should be submitted in both the original language and as certified translations into English.
- Official, sealed transcripts must be submitted prior to enrolling in a degree program.

****University Application Requirements:** Before you enroll in a degree program, you need to submit your university application through [Cal State Apply](#) and pay a \$70 application fee. You don't have to submit this application at the same time as your Intensive English Program application. As you get close to completing the Intensive English Program, the Global Academy office will help you with your application to the university.
