DESCRIPCIÓN DEL CURSO

Los terapeutas de habla y lenguaje que ofrecen servicios en español enfrentan varios desafíos al momento de servir a la comunidad hispanohablante. COURSE DESCRIPTION

There are many challenges currently faced by Spanish-speaking speech-language pathologists, including the need for specific vocabulary, knowledge of dialectical, language and cultural differences; and strategies to address some clients' lack of familiarity with mainstream cultural expectations in United States institutions (e.g., school districts and hospitals). The intention of this course is to improve your familiarity and experience with the above areas, and to inspire you to continue acquiring skills in these areas.
