# I have read and fully understand the responsibilities of placement as indicated on the Placement Acceptance Form.

I understand that participating in the National Student Exchange Program is a privilege and not a right.

I agree to adhere to all the rules and regulations (academic, behaviorial, and financial) of both my home and host institutions and that failure to do so will results in the cancellation of my exchange.

**Health Insurance**: I understand that it is my responsibility to have adequate insurance coverage. I understand that CSUEB cannot guarantee my health and safety while participating in the National Student Exchange. I am solely responsible for acting prudently and exercising caution and common sense at all times.

**Orientation:** Guidance will be provided to participants by the Center for International Education (CIE) in the form of a general predeparture orientation. Students are encouraged to address questions to CIE, as well as to do independent research on their host institution. I am aware that I am required to attend the pre-departure orientation and that I am responsible for understanding the content of all pre-departure and orientation materials.

**Code of Conduct:** CIE requires that all students participating in the National Student Exchange Program read and abide by the *Student Conduct* Code as established by the California State University. A summary of the text can be found at the CSUEB Office of Student Judicial Affairs. The full text of the code is contained in Title V, Section 41301 of the California Code of Regulations and also in the appendix of the University Course Catalog. Students who participate in a certified CSUEB program are responsible for knowing and obeying the applicable rules, policies, and regulations that govern CSUEB, even when they are on exchange. It is the student's responsibility to contact CIE if they have any further questions related to the Student Conduct Code or the expectations and responsibilities of program participants.

Academic Policy: This is an academic program and I acknowledge that I am responsible for attending all classes and scheduled trips, and maintaining a minimum 2.5 G.P.A. Failure to participate fully in the program may constitute academic misconduct and result in dismissal from the program. I also understand that I must follow all CSUEB policies regarding academic integrity and dishonesty.

**Early Departure from the Program:** Voluntary or involuntary departure from the program before its completion does not automatically result in academic withdrawal. While CIE may assist me, I acknowledge that I am solely responsible for resolving my enrollment status if I leave the program early. I further understand that I am solely responsible for any or all cost arising out of my own voluntary or involuntary withdrawal from the program prior to its completion, including withdrawal caused by illness or disciplinary action taken by CSUEB.

#### Photo Release

The purpose of the Family Educational Rights and Privacy Act of 1974 is to protect the privacy of information concerning individual students by placing certain restrictions on the disclosure of information contained in a student's university record. Knowing my right to protect my privacy and to decline that CIE use photographs or videotapes of me in pictures, reproductions, copies, and negatives, I hereby voluntarily give CIE the right to use, sell, transfer, and exhibit in any medium photographs or videotapes of me in university publications or to other assignees of CIE I understand that this authorization remains in effect from today and for five years thereafter. I further understand that it will be necessary for me to send a written letter to revoke this authorization prior to the five year period indicated, should I wish to do so.

(California State University - Executive Order No. 590)

I further agree to and hereby do release and hold harmless the State of California, the Trustees of the California State University, CSUEB and their officers, employees, representatives, volunteers, and agents from any and all claims and causes of action that I may have against any of these institutions or persons, by reason of any accident, illness, injury, death, or other adverse consequences resulting directly or indirectly from or in any manner arising out of, or in connection with, my being a passenger on an airplane pursuant to my participation in the CSU-affiliated program.

## Informed Consent and Release Statement

In consideration of my participation in the National Student Exchange, I hereby covenant and agree as follows:

I understand and agree that neither the State of California, the Trustees of the California State University, CSUEB or any of their officers, employees, representatives, volunteers, and agents, nor any other educational institution associated in this endeavor, shall assume any liability for damage or loss of property or for any financial or other obligations incurred by me either in the United States or elsewhere.

I further specifically agree to waive, release and discharge any and all claims for damages for death, personal injury or property damage against CSUEB and CIE as a result of my participation in the National Student Exchange Program.

This informed consent is intended to fully and completely discharge the State of California, the Trustees of the California State University, CSUEB and their officers, employees, representatives, agents and authorized volunteers, from and against any and all liability arising out of or connected in any way with my participation in this program, even though that liability may arise out of negligence or carelessness on the part of persons or agencies mentioned above. I further understand that accidents and injuries can arise out of transportation to and from, and participation in this program. Knowing the risks, nevertheless, I hereby agree to assume those risks and to release and hold harmless all of the persons or agencies mentioned above who (through negligence or carelessness) might otherwise be liable to me for damages. I also release the CSUEB and its agents and agree to indemnify them with regard to any financial obligations or liabilities that I may personally incur or any damage or injury to the person or property of others that I may cause, while participating in the program. It is further understood and agreed that this informed consent, release and assumption of risk is to be binding on my heirs, assigns, successors and all other persons who may claim through me.

It is further understood and agreed that participants in National Student Exchange Program through CSUEB are subject to the authority of CSUEB, its agents, officers and employees, including sole decision-making responsibility with respect to any participant whose conduct or academic standing may warrant expulsion or withdrawal from the program. Participants are expected to attend classes regularly unless otherwise indicated by illness or unavoidable circumstances. Likewise, as a guide for continued participation, it is understood and agreed that participants are expected to display a sense of maturity and responsibility as a representative of CSUEB, the CSU and the United States of America. I hereby acknowledge and agree that if I am required to withdraw from the National Student Exchange Program for failure to maintain appropriate standards of study or behavior, there will be no refund of tuition after the program departs, and I will no longer have access to any of the facilities arranged for me in the National Student Exchange Program.

I accept the placement offered to me on the National Student Exchange Program. I understand and voluntarily agree to abide by the conditions outlined above.
